The purpose of this program is to provide an alternative instructional setting for students who have not been successful in earning credits at the high school level. Credit Recovery is an independent, self-directed learning environment using a computer-based curriculum and technology for both instructional delivery and student management.

Program Guidelines:

- All subject areas will be delivered by E2020 courseware.
- Lab-facilitators will be certified teachers who have been trained on the E2020 courseware.
- A student may be enrolled in no more than one course per session as long as space is available (1/2 credit maximum).
- Each student and parent will sign a contract stipulating that the student will comply with the guidelines as they pertain to the Credit Recovery program.
- Course requirements must be completed within a maximum of six (6) consecutive weeks.
- Credit will be awarded upon successful completion (70% mastery) of the Credit Recovery course. A certificate of completion will be provided for the student to take to their home school. It is the student's responsibility to make sure the course is approved by their home school prior to registration. The home school counselor or principal must sign the contract prior to registration.
- Payment in the form of a check or money order must be submitted at the time of registration along with this signed contract to the Charlotte High School Guidance Office. Make checks payable to *Charlotte Public Schools*.

Student Requirements/Expectations:

- Students will comply with all student requirements and expectations - **Failure to comply will result in dismissal from the program with no refund.**
- An appropriate learning environment must be maintained.
- Students will not bring food or drink into the lab.
- Students will use the technology equipment and software in an appropriate manner.
- Students will not participate in horseplay.
- Students will work alone and will not share answers. Student's who are not completing their own course requirements may be dropped from the program.
- Printing of lessons will not be allowed without the approval of the lab facilitator.
- Students may ask for help from the lab facilitator.
- Students will monitor their own progress toward reaching the required mastery of 70%.
- Students will have only three (3) attempts to master a lesson; therefore, they are expected to do their best.
- Students will enter and exit E2020 courseware appropriately.
- Unexcused absences may result in the student being dropped from the program. After two excused absences a student may be dropped from the program. A refund will not be provided if a student is dropped.
